FCS e-Connection – February 2012

Dear Colleagues:

March 15th – An Important Date for FCS Programming! FCS Teams Working meeting at Ohio Union and the deadline date for discussing Signature Program proposal ideas with Ken Martin.

With the retirement, loss and moves of 14 FCS educators in the past year, changes have occurred in the sizes of our teams, the formal and informal leaders of those teams, and our capacity within teams. This prompted much conversation last summer and fall among all of us. Based on what we heard from you, we've mapped out a plan to support the teams by creating the 3 focus area teams (Healthy People, Healthy Finances and Healthy Relationships). Those focus teams will each meet three times a year with specialization sub-teams that are working on specific programs. Many of those specialization sub-teams will be the high performing teams with which you are currently actively engaged. The focus teams will provide us with the leadership, communication and synergy across teams that we heard very strongly from you was needed for us to move forward. The March 15th meeting will be a time for us to learn about the types of initiatives the teams have underway and how we can bring additional synergy and communication to our team work. It will also be a time in which we can consider how we streamline and bring efficiency to our teams as a result of our changes in staffing.

Kirk is in the process of summarizing the specialization survey that you completed last week. It is invaluable information that we are already using to answer questions about the types of professional development needed, our capacity to deliver programs and to see where we have programming gaps. This will be very useful information for all of us as we meet on March 15th.

March 15th is also the date prospective new Signature Programs need to share their proposal outline with Ken Martin. The Signature Programs are a core part of the educational programming we provide. Dining with Diabetes, New Start and Real Money Real World have documented impacts of how education through the three "Healthy's" is helping people learn and grow. The Signature Programs have impacted us as an organization too. They have been a visible tool of how we are operationalizing our strategic plan from demonstrating our focus on important issues impacting Ohioans, to expanding our marketing of Extension through highly visible programs. As you are aware, the guidelines for the development of new Signature Programs was sent to all Extension this week. I encourage you to work with your colleagues to develop proposals for this new round of Signature Programs.

OUTBREAK OF SALMONELLOSIS ASSOCIATED WITH PET TURTLE EXPOSURES

The CDC just released a new report entitled "Outbreak of Salmonellosis Associated with Pet Turtle Exposures — United States, 2011". This report describes an outbreak of 132 human Salmonella infections between August 2010 and September 2011 associated with exposure to small turtles (those with shell lengths < 4 inches). Many of these infections occurred in young children, whose illness can be severe and cause hospitalization. Despite a three decade ban on the sale of small turtles, these infections continue to occur. CDC reported similar outbreaks in 2007 and 2008. Increasing enforcement of existing regulations, increasing penalties for illegal sales and emphasizing regulations can assist in decreasing infections acquired from these reptiles. Turtles are not appropriate pets in households with young children or other high risk individuals (pregnant women, older persons and the immune-compromised). We are asking for your help to further distribute this educational flyer to help convey the important prevention messages to any individuals, groups, or organizations involved with turtles and other pet reptiles. We recommend that these flyers be displayed where young children may come into contact with small turtles, like pet stores, flea markets, day care centers, and schools.

Competitive Food Sales in Schools and Childhood Obesity

This longitudinal study looks at the possibility of a link between competitive food sales (chips, candy bars, soda) in schools and the growing rates of childhood obesity in the country. Findings of the study revealed the actuality of the situation – the relationship between competitive food sales and childhood obesity is insignificant, and children's food preferences and dietary patterns begin in the home. AIM FOR THE HEART

Kotter, J. (2008). A sense of urgency. Boston: Harvard Business Press.

For centuries we have had the expression in English, "Great leaders win over the hearts and minds of others." The expression is not, "Great leaders win over the minds of others." More interesting yet, the expression is not that great leaders win the minds and hearts of others. Heart comes first.

History is filled with examples that support this conclusion. Martin Luther King Jr. did not reduce anger among blacks and contentment or anxiety among whites by announcing on the Washington Mall, "I have a strategic plan." King's speech pounded away at people's gut-level feelings with poetic rhetoric and passionate words about justice and morality. He hit hearts in a way that converted anger and anxiety into a commitment to move, do the right thing, and now. (Kotter, p. 45-46)
