Dear Colleagues:

With the ending of one year and the start of a new year, it is always a time for reflection...something I have done a good bit of these last few weeks. Just a few of thoughts about OSU Extension and the FCS program as I have been thinking about the past year and the year ahead ...

- The unique niche of OSU Extension is the interdisciplinary aspect of Extension...and that is the
 power of Extension. What other organization in our society addresses the importance of food from
 "production to consumption"? Who else uses education to empower individuals of all ages AND
 communities to secure and effectively manage resources to address basic needs (food, shelter,
 employment, life skills)? We need to continue to celebrate and build upon our interdisciplinary work.
- Change is not bad...it is just different. We have refined our structure within Extension through the further implementation of our strategic plan. It has created challenges, some sleepless nights and some lively discussions. But through the educational offerings listings we have more clearly stated the value FCS brings to the community. The refinement has given us options to keep positions that may have been lost. It is engaging our stakeholders in new and valuable ways. We have a different way of doing business that is strengthening Extension.
- We can achieve anything in OSU Extension. My family mantra as I was growing up was "can't isn't a word" and I have seen that hold true repeatedly this past year in Extension. We could have looked at the challenges of the federal, state and county budgets and said we "can't" deal with this. Instead we approached the county commissioners and said how "can" we work together to address the budget situation. Looking at the world from the perspective of "can" rather than "can't" makes us more successful.

New programming will expand our work --- like the AFRI Childhood Obesity Grant, Americorps and SNAP-Ed opportunities listed in this newsletter. We will reach new audiences through the efforts of our Marketing Committee, promotion of our health and wellness work with County Commissioners, new grants and revised efforts of our Healthy People, Healthy Finances and Healthy Relationships teams. I look forward to working with all of you as we move ahead in 2012.

SNAP-ED (FNP) OPPORTUNITIES FOR FY2013

If your county does not participate in the FY2012 Ohio Family Nutrition Program Project (also known as Supplemental Nutrition Assistance Program Education, SNAP-Ed) and you would like information about applying for the FY2013 project, e-mail your name and contact information to Joyce McDowell, Leader, Community Nutrition Projects <mcdowell.1@osu.edu>. Joyce will add you to the listserv that includes dates for training about the proposal and dates for submitting a proposal. The FY2013 Family Nutrition Program budget will not require cost share match. The Ohio Family Nutrition Program proposal is approved by the Ohio Department of Job and Family Services, and then by the USDA Food and Nutrition Service. Approval of the OSU Extension proposal and its "unit projects" is based in part upon available Ohio SNAP-Ed funding, county Department of Job and Family Services support, and quality of the proposed project as related to the SNAP-Ed guidance.

OPPORTUNITY TO HOST AMERICORPS VOLUNTEERS

With funding from an AmeriCorps Grant, OSU County Extension offices will have the opportunity to host AmeriCorps volunteers for one year starting this August. The AmeriCorps volunteers will (1) actively engage in community-based outreach to inform troubled homeowners about foreclosure mitigation programs in Ohio, and (2) assist homeowners who have received assistance through Ohiowide foreclosure mitigation programs, such as Restoring Stability, with financial management to prevent re-default. In addition, the volunteers will help with general financial education programming.

Ideally, we would like to assign volunteers to locations in pairs to create working teams. Extension offices will need to provide work space, access to office equipment, a few supplies, and minimal supervision. The volunteers will arrive at your offices trained and ready to begin work on this project.

Staska Keefer, the new grant-funded program manager working with Caezilia Loibl, Consumer Sciences State Specialist, will coordinate this project and supervise the AmeriCorps volunteers. Staska will ensure the volunteers are trained and not a burden to your offices, but a fantastic resource for your communities. We plan to hire the AmeriCorps volunteers through the national AmeriCorps database, unless you have suitable candidates in the area you would recommend.

Census Shows that 1 in 2 Americans are Poor or Low-Income

A record number of Americans are now considered to be low-income, and the middle-class is still shrinking according to newly released Census data. Factors contributing to this increase include the rising cost of housing expenses, as well as job loss or pay cuts. Housing and child-care costs now consume up

to half of a family's income, putting increasing pressure on families who may have already been struggling financially before the recession. By age, children were most likely to be poor or low-income — about 57%— followed by seniors over 65. By race and ethnicity, Hispanics topped the list at 73%, followed by blacks, Asians and non-Hispanic whites. Ideas of Acceptable Weight Later in Life Form During Early Childhood

British researchers have found that an individual's concept of acceptable weight is formed during childhood and is not significantly influenced by later social networks. Because of this, they suggest obesity prevention strategies should be implemented in early childhood and at the household level if they are to be effective.

Breastfeeding Promotes Healthy Growth

A PhD project from the Life Sciences department at the University of Copenhagen has shown that breastfed children follow a different growth pattern than non-breastfed children. Breastfeeding lowers the levels of the growth hormones IGF-I and insulin in the blood, which means that growth is slightly slower. This is believed to reduce the risk of overweight and diabetes later in life. Additionally, there was a correlation between how long the child was breastfed and their weight at 18 months. Poor Kids Miss out on Playtime, Pediatricians Say

Children in poor urban neighborhoods are missing out on old-fashioned playtime in their daily lives (both indoors and outdoors.) The new reports from the American Academy of Pediatrics (AAP), follows another from the AAP a few years ago, which argued that U.S. suburban children are "overscheduled" with formal classes and lessons, leaving them little time for simple play. For poor children, in cities in particular, the problems are a lack of safe places to play, parents who are busy trying to pay for housing and other basics and schools that are cutting out recess and physical education to make more time for academics
