### Level 2 (Manager) Training

Food safety training for managers, operators, and owners. Upon successful completion of the course and exam, participants receive a **Certificate of Completion** from ServSafe and an **Ohio Food Protection Card** from ODH. Must attend all class dates.

### Level 1 (Employee) Training

One-day basic food safety training which meets ODH Level 1 training requirements; program includes a handbook, activities and a **Certificate of Completion**.

**November 13, 9:00 a.m. - 2:00 p.m.**

### Level 2 Online Training

Online training is available for those unable to attend a physical class. Test dates are as follows: February 28, April 10, August 29, October 24, and November 13. Other test dates available by appointment.
