## Words You May See on Packages

What They Mean

Whole grain [name of grain]

Whole wheat

Whole [other grain]

Stone-ground whole [name of grain]

Brown or wild rice

Oats or oatmeal

Wheat berries

Organic whole grain [name of grain]

**YES.** All of these are whole grains.

They contain all parts of the grain, so you're getting all of the nutrients of the whole grain.

Wheat or wheat flour

Semolina

**Durum** wheat

Organic flour

Stone-ground

Multigrain (can describe any mix of grains, whole or refined)

**Enriched flour** 

Degerminated

Bran

Wheat germ

**MAYBE.** These may or may not be whole grains.

They are accurate descriptions of the package's contents, but they do not ensure all parts of the grain are included.

**NO.** These words never describe whole grains.
